Willamette Valley USBC 61st Annual Open Tournament
Rules and Regulations

All Rules and Regulations of the United States Bowling Congress shall apply.

- 1) Any individual having won \$300.00 or more in a tournament in the past twelve (12) months must report such winnings at the time of entry.
- 2) Entries can be accepted from members of the WVUSBC up to one hour before the last squad of the open tournament. Entries can be accepted from members of the WVUSBC with 21 games or more, or last years book average. If not WVUSBC member you may purchase a membership card for \$7.00. Non USBC members may purchase a card for \$18.00.
- 3) **AVERAGE QUALIFICATIONS:** USBC Rule #319a #2 & 319b will be waived for this tournament.
 - a.) Bowlers will use 2007/2008 current high book average.
 - b.) If no winter average, use summer 2008 average as of 21 games
 - c.) If none of the above, use 2006/2007 Highest book average.
 - d.) If the bowler is a new bowler, then use current average as of December 1, 2008.
 - e.) If no 2006/2007 average or current average of 21 games, bowler will use 220 average.
- 4) Teams will consist of four (4) members. No change in the line up order after entry has been submitted. No more than one (1) PBA (Professional Bowling Assoc.) member may be on a team, nor more than one (1) PBA member on doubles.
- 5) A bowler may bowl in any event (except Singles and All Events) more than once. In the team event, no more than two players on one team may cash more than once per division. In doubles you may only cash once with the same partner per division. In singles you may only cash once per division. A Bowler's first Team/Doubles with Singles will count towards their All Events Scores.
- 6) Singles and the First Doubles will be bowled as one squad and both must be bowled together. "All Events" is optional.
- 7) Handicaps will be based on 90% of the difference between entering average and 220. Request for substitutions in line-up must be made to the tournament director one (1) hour prior to the scheduled bowling time.
- 8) Team Captains must submit USBC CARDS for the team members to the tournament director thirty (30) minutes prior to the scheduled bowling time. If there is no USBC card, you are subject to disqualification.
- 9) Tardy Teams or Bowlers will be penalized with a zero score for the frames missed.
- 10) **NO ENTRY WILL BE ACCEPTED WITHOUT FULL PAYMENT.** No entry fee will be refunded after entry has been received and dates and time have been assigned. Any bowler with a returned check will be charged double the amount of the check. Plus bank fees.
- 11) **Entries will be accepted up to 1 hour before the last squad bowling.** Any team/doubles/singles entries that wish to bowl must pay in cash-or entries received after March 1, 2009 must pay in cash to the tournament director.
- 12) **Dress Code:** Bowlers must wear a shirt with a collar, they may have a legitimate sponsor and/or bowler's name. No headgear allowed. Dress slacks or good jeans required. No sweats will be allowed. Dress shorts must be mid thigh to above knee and have a hem. No bare midriffs.
UNDERGARMENTS MUST BE COMPLETELY COVERED. Tournament manager will have the final approval. You may be disqualified for non compliance.
- 13) It is the team captain's responsibility to ensure that all bowlers understand and abide by the tournament rules.
- 14) If you enter the tournament with a false average, you will be disqualified.
- 15) All questions or concerns will be decided by the Tournament Director.
