## OFFICER'S INVITATIONAL TOURNAMENT – RULES

1. Teams must consist of at least one officer (which includes all members of the Board of Directors, Life Member and Member Emeritus from the Salem BA and WBA and Stayton WBA). In the event that an officer needs to withdraw from the tournament at the last minute a team must still have at least one officer on the team to participate. NO EXCEPTIONS.
2. Only one three-game team series will be bowled. YOU MAY PARTICIPATE ONLY ONCE!
3. Entering averages:
  - a. Highest yearbook average for past season (2007-2008)
  - b. Highest current summer league average for at least 21 games
  - c. Current high league average for at least 21 games, as of January 1, 2009
  - d. If none of the above, women will use 190 and men 210.
4. Handicap: 90% of the difference between team total average and 850. Teams over 850 will have a 100% minus handicap for all pins over 850
5. Total entry fee must accompany entry. Any returned checks will have a \$30 charge.
6. USBC rules 319a and 319e will not apply in this tournament.
7. Prize money will be returned 100%. Ratio is 1 to 5 or major fraction thereof.
8. All other USBC rules apply.
9. Management of the tournament is vested in the Willamette Valley USBC Association, Tournament Committee.
